JUNIOR DOUBLE RINK 2024 - SUNDAY 28th JULY AT LLANDRINDOD WELLS BC

RULES:-

1	Each side shall comprise of two teams of four male bowlers who were under 25 years old on 1st April 2024. Normal fours regulations will apply with the exception of the conditions stipulated below.
2	All team managers should report to the competition secretary 30 minutes before their first game to submit names of players & the reserve (a printed copy of teams is requested, this can also be sent to the competition secretary by email in advance of the day). The team Managers (or Captains) should report to the competition secretary 15 minutes prior to the scheduled start of each round of group games, where the competition secretary shall issue scorecards for their next game. The team managers (or captains) will be responsible for tossing a coin to decide rinks and completing names of players on the scorecards. All scorecards must be returned to the competition secretary duly signed by each skip to confirm the score is correct. All bowls must be placed on green at 9am (or 10:30 in the case of team "9") for inspection by the umpire.
3	Play in each group stage game shall be over a maximum of 8 ends after 1 trial end has been played but must not exceed a duration of 1 hour (which includes the trial end). Due to the busy schedule, only one visit to the head per team per end by the third or skip in group games will be allowed. A bell (or whistle) will be sounded at the commencement & end of each session. When the bell (or whistle) is sounded to signify the end of play, all ends in progress must be completed before play stops. If at the time of the bell (or whistle) sounding to signify the end of play, the lead had already legally cast a jack (irrespective of whether it had been yet centered) to begin a new end, then that end shall be completed before play stops. Umpires will be asked to enforce this rule strictly in order to ensure the schedule goes smoothly and games does not overrun.
4	One reserve is permitted per side. Team managers can use the reserve at their discretion.
5	Dress code:- white shorts or trousers & club or county tops. No alcohol to be consumed during play, or mobile phones to be used on the green.
6	The winners of group games shall be the side that scores the highest number of combined shots (of the two rinks). Winners of each game shall be awarded two points, for a drawn game each side will be awarded one point. A record of shot aggregate and ends won will be kept by the competition secretary.
7	The sides which finish first and second in the group shall play in the final. These shall be the sides which have the highest number of points. If there is a tie for points between two or more sides for the top two positions in the group then the side with the highest shot aggregate shall qualify. If this is still tied then the side that have won the most number of ends shall qualify. If still tied, a "one end decider" will be played with Team Managers (or Captains) tossing a coin to decide who plays first. If the result of the "one end decider" is a tie then the process is repeated until a winner emerges.
8	The final shall be played over 12 ends with two trial ends and no restrictions on visits to the head. If scores are tied after 12 ends , the two sides will play a "one end decider" until a winner emerges (as described above).
9	The Competition secretary shall have the authority to amend the schedule or rules as they deem necessary for the best interests of players and the competition itself. In case of any dispute, query or challenge to the rules , the decision of the competition secretary is final & irrevocable.
